



### IMPORTANT SAFEGUARDS

When using electrical equipment, basic safety precautions should always be followed including the following:

**READ AND FOLLOW ALL SAFETY INSTRUCTIONS.**

#### WARNING

To reduce the risk of death, personal injury or property damage from fire, electric shock, falling parts, cuts/abrasions, and other hazards read all warnings and instructions included with and on the fixture box and all fixture labels.

Before installing, servicing, or performing routine maintenance upon this equipment, follow these general precautions.

- Commercial installation, service and maintenance of luminaires should be performed by a qualified licensed electrician.

For the installation: If you are unsure about the installation or maintenance of the luminaires, consult a qualified licensed electrician and check your local electrical code.

- To prevent wiring damage or abrasion, do not expose wiring to edges of sheet metal or other sharp objects.

- Do not make or alter any open holes in an enclosure of wiring or electrical components during kit installation.

#### WARNING

- Turn off electrical power at fuse or circuit breaker box before wiring fixture to the power supply.

- Turn off the power when you perform any maintenance.

- Verify that supply voltage is correct by comparing it with the luminaire label information.

- All wiring connections should be capped with UL approved wire connectors.

#### CAUTION

- Avoid direct eye exposure to the light source while it is on.

- Account for small parts and destroy packing material, as these may be hazardous to children.

#### NOTICE:

- Risk of burn. Disconnect power and allow fixture to cool before changing handling fixture.

Green ground screw provided in proper location. Do not relocate.





### What's In The Box




### Tools & Materials Needed

A screwdriver, drill, wire cutters, four (4) screws, and four (4) anchor bolts will be needed to install the WPC.




### GENERAL STEPS

Carefully unpack fixture from packaging and inspect for any damage caused in shipping.





Turn off power to appropriate circuit at the breaker panel.



### STEP 1: PREPARE FIXTURE FOR SURFACE MOUNTING


Remove lens from housing by opening latch on endcap and prying lens away from the fixture.

Step 1: Open the flip-top on end-cap, remove the lens directly.




### STEP 2: PREPARE MOUNTING SURFACE

The WPC4 can be mounted directly to the surface OR mounted directly to a junction box. To mount directly to the surface use the luminaire housing as a template and line up the power feed hole with the junction box. Then mark the locations of the four (4) screw holes on the feet of the fixture. If necessary, install anchor bolts at the marked locations.



### STEP 3: ELECTRICAL CONNECTIONS

Make electrical connections per the wiring diagram.



### STEP 4: WATTAGE/CCT SELECTION

To adjust CCT or Wattage (lumen output), adjust the switch positions on the side of the body to the desired setting.


Note:

- 1) Power selection switch is a four-position switch that will adjust light output: HIGH/MEDIUM/LOW/MIN.
- 2) CCT selection switch is a five-position switch that will adjust Color Temperature between 3000K, 3500K, 4000K, 5000K, 6500K.




### STEP 5: INSTALL FIXTURE

If mounting directly to surface, place fixture against mounting surface and install four (4) screws into marked locations/anchor bolts.




If mounting to junction box, place fixture against junction box and install two (2) screws through junction box mounting holes and into junction box mounting tabs.

#### Surface mount to junction box




### STEP 5a: FIXTURE WITH BATTERY BACKUP

Installation of a fixture with battery backup is identical to a normal fixture except for the wiring. Follow wiring diagram shown here for EM version wiring.




Make electrical connections per the wiring diagram.



### STEP 6: REINSTALL LENS

Reinstall lens starting at one end of housing. Insert lens slot onto edge of housing and carefully squeeze lens to engage opposite side with housing. Continue this action down length of lens until fully installed onto housing. Close lens latch.

The product shall be considered defective only if 10% or more of the product's LED components fail. NICOR LED product warranty covers the following performance criteria: LED Light Output will be maintained above 70% of initial output; LED color temperature will not shift more than 200K in CCT; LED driver will operate within NICOR specifications; and the fixture finish, excluding natural aluminum or brass products, will not exhibit cracking, peeling, excessive fading, or corrosion during the warranty period. Exceptions apply as defined in NICOR's product specification sheets, which are incorporated by reference herein.

This limited warranty is provided to you, the purchaser of the product identified on Seller's invoice, as your exclusive remedy and applies only to NICOR products that have been purchased from an authorized NICOR Distributor; the product was new and in an unopened NICOR package at the time of installation; and the NICOR product was installed by a licensed electrician or under the supervision of a licensed electrician and used by consumers in the United States or Canada when accompanied with this warranty. This warranty extends only to the first consumer purchaser and is not transferable. A consumer wishing to invoke the terms of this limited warranty must first obtain a RGA number within 30 days of discovery of the defect, and return the product to NICOR for inspection. Once verified to be covered by this limited warranty, NICOR will, at its sole discretion, repair, replace, or refund the purchase price of any product that does not conform to this limited warranty. If NICOR, at its sole discretion, determines that the product should be repaired or replaced, this warranty is limited to the reasonable, customary, and necessary costs and expenses associated with the repair/replacement. This warranty requires that all repair/replacement estimates and costs, including but not limited to equipment rental (if any), and any other cost or expense to be incurred in the repair/replacement of the product, be approved in advance and in writing by NICOR. FAILURE TO OBTAIN NICOR'S ADVANCE WRITTEN APPROVAL OF ALL REPAIR/REPLACEMENT COSTS AND EXPENSES IN WRITING SHALL VOID THIS LIMITED WARRANTY.
